- c) Unless, within thirty (30) days of receiving notice of the lien, the undersigned company posts cash or a letter of credit at sight, or, if the amount due is in dispute, and acceptable bond equal to 110% of the value of the total amount due in GlobeRunners Inc.'s favor, guaranteeing payment of the monies owed, plus all storage charges accrued or to be accrued, GlobeRunners Inc. shall have the right to sell such shipment(s) at public or private sale or auction and any net proceeds remaining thereafter shall be refunded to the undersigned comp any.
